The cost of such insurance shall be borne by the Subcontractor and shall remain in force until the material is received at the Project site;

5. The Subcontractor agrees that in the event the material sustains any damage or is stolen, whether compensated for by insurance or not, the Subcontractor shall obtain like materials at no additional cost to the Contractor.
